Memorandum of Agreement**

This AGREEMENT is made, by and between, Nye Communities Coalition whose address is 1020 East Wilson Road, Pahrump, Nevada, 89048 hereinafter referred to as "Coalition" and/or "NyeCC" and Nye County Sheriff Office, Contractor's FEIN: 88-6000111, whose address is 1520 E. Basin Ave., Pahrump, NV 89048 hereinafter referred to as "Contractor" and/or "NCSO".


WHEREAS, Coalition desires to engage the services of Contractor to perform alcohol compliance checks throughout Nye County.

NOW, THEREFORE, it is agreed as follows:


1. **Term:** The respective duties and obligations of the Contractor shall be commencing on the July 27, 2020 and ending on the June 30, 2021.
2. **Scope of Work:** (Reference Attachment A)
3. **Compensation.** Contractor shall receive from Coalition a total sum of \$2,000 pursuant to the terms and scope of work of this agreement.
4. **Liability.** The Coalition, pursuant to the terms and scope of work of this agreement, shall not be liable to the Contractor, or to anyone who may claim any right due to any relationship with the Contractor, except when said acts or omissions of the Coalition, are due to willful misconduct or gross negligence. The Contractor shall hold the Coalition, free and harmless from any obligations, costs, claims, judgments, attorneys' fees, and attachments arising from or growing out of the services rendered to the Coalition pursuant to the terms of this agreement or in any way connected with the rendering of services, except when the same shall arise due to the willful misconduct or negligence of the Coalition.
5. **Termination:** This agreement may be terminated by either party giving a thirty (30) day written notice to either party at the addresses stated herein or at an address chosen subsequent to the execution of this agreement and duly communicated to the party giving notice.

Attachment A - Scope of Work

- A.) NCSO will work with NyECC to build-up systems of alcohol compliance checks.
- B.) NCSO will have officers trained in compliance check and shoulder taps through NyE Communities Coalition.
- C.) NCSO will work in collaboration with NyE Communities Coalition to complete compliance checks for alcohol retail stores throughout Nye County.

D.) NCSO will work in collaboration with NyE communities Coalition to complete shoulder taps in Nye County.

E.) NCSO will communicate with the retail store following the completion of the compliance check to notify of the pass/fail status, and, if applicable, suggest tools that will support individuals with the legal alcohol sale age.

F.) NCSO will develop a community communication plan to notify commissioners and community members of the compliance check results.

G.) NCSO will present at County Commissioner meeting with support of NyE Communities Coalition to look at strengthening local ordinance to have the fine go to the business owner rather than the individual.

H.) NCSO will submit an invoice by end term of this contract.
